A. Council to Introduce Ordinance No. 008-2020 to remove a portion of the road located on Black Lake N/2Ne/4 of Sec 9, T11N-R7W at the end of Cloud Crossing Road which is the last 1,130 feet of Cloud Crossing Road from the Parish Road System.

B. Council to Introduce Ordinance No. 009-2020 for Budget Amendments for Government Building Fund, Criminal Jury Compensation Fund, Law Enforcement Officer Criminal Witness Fund, Disaster Recovery Fund, and the Courthouse Security Capital Outlay Fund.

Public Hearings:

A. Council to adopt Ordinance No 006-2020 to affect a zoning change from I-A Industry-Agriculture District to a B-I Business District for the purpose of establishing a medical clinic on a 2.62 acre tract of land, parcel #0063008500, situated in Section 9, T8N, R9W along Highway 6 in Robeline, as shown on the Survey attached hereto, approved by the Parish Planning Commission on April 6, 2020.

Action on Proposed Ordinances:

A. Council to adopt Ordinance No 006-2020 to affect a zoning change from I-A Industry-Agriculture District to a B-I Business District for the purpose of establishing a medical clinic on a 2.62 acre tract of land, parcel #0063008500, situated in Section 9, T8N, R9W along Highway 6 in Robeline, as shown on the Survey attached hereto, approved by the Parish Planning Commission on April 6, 2020.

Resolutions:

A. Council to adopt Resolution 031-2020 to change the polling place for the July 11 Presidential Preference Primary and Municipal elections and for the August 15, 2020 if we have City of Natchitoches election run-offs. This move is from the Council on Aging Building because statewide, Senior Citizen Centers cannot be used as polling places during the COVID-19 emergency. The Council on Aging building address is 1016 Keyser Avenue and the new address will be the Masonic Lodge at 110 Masonic Drive.

B. Council to adopt Resolution 033-2020 in accordance with the requirements of the Community Water Enrichment Fund Program to support and cordially request grant authorization to execute and submit an application for the 2019-2020 Community Water Enrichment Fund Program for the Sandy Point 480 Water System in the amount of \$300,000.

11. Other Agenda Items:

A. Council to consider authorizing the Parish President to sign and execute an Online Subscription Agreement with Dude Solutions, Inc., which will allow Department of Public Works Employees and members of the general public to have an online tool that tracks completed and ongoing projects performed by the Department of Public Works.

B. Council to consider authorizing the Parish President to enter into an agreement with Tony Tillman to provide services in the creation and execution of an agreement pertaining to the donation of the Payne Subdivision Sewer System from Total Environmental Solutions, Inc.

C. Council to authorize Parish President to negotiate renewal lease for the Derry Solid Waste Site.

D. Council to authorize the additional \$1100 dollars to the current amount of \$7500 for a total amount of \$8600 per year to the Natchitoches Parish 4-H office.
